#### IATTC IUU VESSEL LIST

IATTC Resolution <u>C-15-01</u>, which amended and replaced IATTC Resolution C-05-07, requires the establishment of a list of vessels presumed to have carried out illegal, unreported and unregulated (IUU) fishing activities in the eastern Pacific Ocean (EPO), based on information collected by Members and Cooperating Non-Members (CPCs) and from any other relevant sources.

In addition to describing in detail the procedure for compiling the List, Resolution C-15-01 also establishes, *inter alia*, that:

- 1. The Committee for the Review of the Implementation of Measures Adopted by the Commission (Review Committee) shall each year examine the provisional IATTC IUU Vessel List, as well as the information that supports the inclusion, and shall remove a vessel from the provisional IATTC IUU Vessel List if the vessel's flag State demonstrates that:
  - a. The vessel did not engage in any of the IUU fishing activities described in paragraph 3 of Resolution C-15-01, or
  - b. Effective action has been taken in response to the IUU fishing activities in question, including, *inter alia*, prosecution, and imposition of sanctions of adequate severity.
- 2. Following the examination referred to in the above paragraph, the Review Committee shall recommend that the Commission approve the provisional IATTC IUU Vessel List, as amended by the Review Committee.

As notified by the Director to the CPCs (memorandum ref. 0291-410 dated 22 May 20197) and as of the date of preparation of this document, no vessels were proposed by a CPC for inclusion in the IUU List and, therefore, included in the draft IUU list.

Therefore, as previously on similar occasions, there will be no provisional list this year other than the current IUU vessel list (attached).

The vessels on the current IUU Vessel List will remain on that list until the Commission decides otherwise.
