- 4) Consideration of the implementation of compatible measures

**5. Preparing WCPFC's 2027 SPA stock assessment**

The JWG will consider the following issues, but not limited to, as needed.

- 1) Scope of assessment (WCPO or pan-Pacific)
- 2) Framework for coordination between SPC and IATTC scientists
- 3) Data requirements and exchange

4) Review of Close-Kin Mark-Recapture (CKMR) results and planning for future application in South Pacific albacore assessments
