COOPERATING NON-MEMBERS

In 2004 the IATTC adopted Resolution $\underline{C-04-02}$, which established the criteria for attaining the status of cooperating non-Party or cooperating fishing entity. These criteria include requirements relating to the provision of information, compliance with conservation and management measures, and participation in meetings. In 2007 the IATTC adopted Resolution $\underline{C-07-02}$, which replaced C-04-02.

The Resolution establishes that, each year, the Director shall contact all non-Members with vessels fishing for species covered by the IATTC Convention to urge them to become a Member of the IATTC or to attain the status of a Cooperating Non-Member (Cooperating Status).

The Resolution further establishes that any non-Member that seeks to be accorded Cooperating Status shall apply to the Director requesting such status. Such requests must be received by the Director no later than ninety (90) days in advance of an annual meeting of the Commission in order to be considered at that meeting.

The Resolution also states that the Joint IATTC-AIDCP Working Group on Fishing by non-Parties shall be responsible for reviewing requests for Cooperating Status and for recommending to the Commission whether an applicant should receive Cooperating Status. In view of the dissolution of that Working Group, this function has now been assumed by the Committee for the Review of Implementation of Measures Adopted by the Commission ("Review Committee") in matters related to the IATTC.

At its 90th meeting in July 2016, upon recommendation of the Review Committee, the IATTC agreed to renew the Cooperating Non-Member status of Bolivia, Honduras, Indonesia, and Liberia and considered "communicating an admonition that the Commission would not renew the status in future years if the CPCs did not participate in the Commission's subsidiary bodies".

Article XXVI, paragraph 1, of the Antigua Convention also states that "*The Commission and its members shall encourage all States and regional economic integration organizations* [...] *and, as appropriate, fishing entities* [...] *that are not members of the Commission to become members or to adopt laws and regulations consistent with the Convention.*" Accordingly, the Secretariat sent letters to Bolivia, Chile, Honduras, Indonesia, and Liberia. Likewise, letters were sent to Colombia, Ecuador, Peru, Vanuatu and Venezuela in order to determine their situation vis-a-vis ratification of, or accession to, the Antigua Convention.

The Director received and circulated letters from Bolivia, Honduras, Indonesia, and Liberia requesting the renewal of their status of Cooperating Non-Member of the IATTC, as well as from Chile asking for the granting of that status. (Appendices 1 to 5).

- a) Nominal catches;
- b) Number/type of vessels;
- c) Name of fishing vessels;
- d) Fishing effort/fishing areas.

Liberia

NOTE: This requirement does not apply to Liberia for non-domestic fishing activities. Currently, Liberia only has carrier and supply vessels authorized to engage in transshipment activities in the IATTC Convention Area. In the event there is consideration for registration of fishing vessels in IATTC's Convention Area, Liberia will provide notification of the same.

ATTACHMENT 2

Requirement: Details on Current Fishing Presence in the IATTC Area, Number of Vessels and Characteristics:

Liberia: This requirement does not apply to Liberia for non-domestic fishing activities. However, Liberia has in its Registry a number of carrier and supply vessel that participate in transshipment activities. IATTC has been provided the most current Record of Vessels.

ATTACHMENT 3

Requirement: Information on any Research Programs that Liberia has Conducted in the IATTC Area and Results:

Liberia: This requirement does not apply to Liberia. In the event there is consideration for research programs in IATTC's Convention Area, Liberia will provide the requisite information.

Requirement: Commitment to Respect ALL Conservation and Management Measures in Force in IATTC

Liberia makes this explicit commitment to respect all conservation and management measures (CMMs) in force in IATTC, including but not limited to:

- C-03-04: At-sea reporting.

ATTACHMENT 5

Requirement: Commitment to Respect the Capacity Limits Already in Force in IATTC for Tuna Vessels

Liberia makes a commitment to respect the capacity limits already in force in the IATTC Convention Area for tuna vessels.

Requirement: Inform the IATTC of all Management and Conservation Measures Liberia takes to Ensure Compliance by Vessels, including: Inspection at Sea and in Port Vessel Monitoring Systems.

Liberia makes an explicit commitment to inform the IATTC of all conservation and management measures it takes to ensure compliance with at-sea and in port inspection and vessel monitoring systems.

<u>Monitoring</u>: Liberia has established Vessel Monitoring System (VMS) requirements for all vessels that engage in transshipment activities through our transshipment licensing program. Vessels engaged in transshipment activities transmit location/positions to our Fish Monitoring Center (FMC) once every hour.

<u>Contacts</u>: The Liberian Registry has 17 offices globally and nearly 400 Flag State inspectors at all major shipping ports. The head office of the Registry is in Vienna, Virginia, USA, which is where we operate our Flag FMC for vessels engaged in transshipment activities.

Inspection/Investigation: If one of our vessels is inspected and an infringement is found, the Liberian Registry has the authority to send a vessel to port pursuant to Liberian Maritime Regulations (RLM-108) for an inspection and/or investigation. Regulations are made by the Commissioner of Liberia Maritime Authority under the powers conferred by section 11 of Chapter 1 of Title 21 of the Laws of The Republic of Liberia (the Maritime Law).

ATTACHMENT 7

Requirement: Commitment to Respond to Alleged Violations of IATTC Measures by Vessels...Communicate to IATTC the Actions Taken Against the Vessels

Liberia makes an explicit commitment to respond to alleged violations of IATTC measures (including IUU fishing) by vessels, as determined by the appropriate bodies, and will communicate to IATTC the actions taken against those vessels.

Our country is in position to ensure compliance of the measures, through the proper monitoring, control and surveillance of vessels under national flag, such as the satellite vessel monitoring system (VMS), scientific observer programs, inspection at sea and in port, programs which shall be duly informed of the Commission;
- d. Our country is committed to respond to alleged violations of measures in force adopted by the Commission;
- e. Chile shall participate at plenary and relevant subsidiary and scientific meetings.

INDONESIA'S APPLICATION FOR COOPERATING NON-MEMBER STATUS OF INTER-AMERICAN TROPICAL TUNA COMMISSION (IATTC)

I. Introduction

Indonesia is one of the largest tuna producing countries in the world. Tuna resources are spread out almost all over Indonesia waters include archipelagic and territorial waters as well as IEEZ. Contribution of tuna fishery both to gross domestic product (GDP) and working opportunity cannot be ignored. Tuna also is one of the primary export commodities that are exported in various products such as fresh tuna, frozen tuna, canned tuna. In 2011, export of tuna products (fresh, frozen and canned) to Japan, USA, EU, Canada, China and Korea.

As we are aware, Regional Fisheries Management Organisations (RFMOs) are of central importance to sustainable management tuna resources in the world. In 2004, the Government of Indonesia has drawn line policies according to Fisheries Law No. 31 of 2004 which is also based on UNCLOS 1982. The Law has explicitly provided room for the Government of Indonesia to participate actively in the membership of body /institution/organization at the regional or international level with respect to the cooperation for regional and international fishery management, such as cooperation for conservation and management of straddling and highly migratory fish stocks through existing RFMOs.

Currently, Indonesia has actively participated in the Regional Fisheries Management Organizations (RFMOs) namely: (i) Indian Ocean Tuna Commission (IOTC) as a member since 2007, (ii) Commission for the Conservation of Southern Bluefin Tuna (CCSBT) as a member since 2008. and (iii) Western and Central Pacific Fisheries Commission (WCPFC) as a member since 2013. This participation refletcs a commitment of Indonesia to be involved in achieving sustainable fisheries management through international cooperation.

Since 2004, Indonesia has participated in IATTC Annual Meeting and renew the status annually. With reference to the Resolution C-07-02 on Criteria for Attaining the Status of Cooperating Non Party or Fishing Entity in IATTC, Indonesia would like to renew the status of Indonesia as Cooperating Non Member to the IATTC for the year of 2016/2017. Indonesia strongly believes that Indonesia's membership could improve its role and give strong foundation for strengthening future cooperation through Regional Fisheries Management Organizations (RFMOs).

II. Submission of Indonesia fulfillment requirements become Cooperating Non Member of IATTC as required in Resolution C-07-02

a. Information requirements

Communicate full data on its historical fisheries in the IATTC area, including nominal catches, number/type of vessels, name of fishing vessels, fishing effort and fishing areas; There was no Indonesia flagged vessels operating in the convention area of IATTC.

Communicate annually catch and effort data and size-frequency distribution of the catches (when possible) in due time and appropriate format for scientific evaluation of the stocks;

Indonesia did not have any catch and effort data and size-frequency distribution of the catches in IATTC area.

Communicate details on current fishing presence in the area, number of vessels and vessel characteristics;

There was no Indonesia flagged vessels operating in the convention area of IATTC.

Communicate research programs it has conducted in the LATTC area and share the information and the results with the LATTC.

None. Indonesia did not conduct research programs in the IATTC area.

b. Compliance requirements

Respect all conservation measures in force in IATTC

Indonesia commits to cooperate in the implementation of conservation and management measures adopted by IATTC. Indonesia also will ensure, to greatest extent possible, its nationals policy comply with the provisions of the Convention and conservation and management measures adopted by IATTC.

Respect the capacity limits already in force in IATTC for tuna vessels;

None. There was no Indonesia flagged vessels operating in the convention area of IATTC.

Inform the IATTC of all the management and conservation measures it takes to ensure compliance by its vessels, including inter alia and as appropriate, observer programs, inspection at sea and in port, and Vessel Monitoring Systems (VMS);

- Presidential Decree No. 9 of 2007 on Ratification of the Agreement for the Establishment of the Indian Ocean Tuna Commission (Agreement on the establishment of the Indian Ocean Tuna Commission);
- Presidential Decree No. 109 of 2009 on the Ratification Convention for the Conservation of Southern Bluefin Tuna.

- Ministerial Decree No. 07/MEN/2010 regarding Certitificate of Seaworthiness Fisheries Vessels;
- DG of Capture Fisheries Decree No. Kep.51/DJ-PT/2012 Regarding Arrangement of Fisheries Vessels in Fishing Port.
