### **COOPERATING NON-MEMBERS**

At its 92<sup>nd</sup> meeting in June 2017, upon the recommendation of the Review Committee, the IATTC renewed the Cooperating Non-Member status of Bolivia, Honduras, Indonesia, and Liberia, and granted it to Chile. In the case of Indonesia, which was absent from the meeting, the Commission decided that "a letter should be sent to the country to remind it forcefully of the obligations of CPCs, which include Cooperating Non-Members, to attend the annual meetings of the IATTC and its subsidiary bodies".

In accordance with the procedures and deadlines established in Resolution <u>C-07-02</u>, the Director sent letters to the five Cooperating Non-Members, and received their requests for renewal of that status, which were duly circulated and are reproduced below (Appendices 1 to 5).

In compliance with paragraph 5 of the Resolution, the Committee is expected to review these requests and to make a recommendation to the Commission.

- c. Our country is in position to ensure compliance of the measures, through the proper monitoring, control and surveillance of vessels under national flag, such as the satellite vessel monitoring system (VMS), scientific observer programs, inspection at sea and in port, programs which are being duly informed to the Commission;
- Our country is committed to respond to alleged violations of measures in force adopted by the Commission;
- e. Chile shall participate at plenary and relevant subsidiary and scientific meetings.

Receive a cordial greeting from the Undersecretariat for Livestock of the Secretariat for Agriculture and Livestock of Honduras.

On this occasion, I wish to express to you and to the Inter-American Tropical Tuna Commission (CIAT) the interest of Honduras in renewing the status of Cooperating Non-Party, in accordance with paragraph 6 of Resolution C-07-02 of the Commission.

At the same time, we express our willingness to continue, as we have already done, carrying forward the provisions of resolution C-07-02 of the Commission while the process of accession of Honduras to the Antigua Convention is moving forward.

For this reason, the Commission has already information related to Honduras data on historical fisheries in the IATTC area; annual catch and effort data and the length-frequency distribution of catches as well as our current fishing presence in the area.

Although at the moment it was not possible to develop individually research programs in the area of the IATTC, we reiterate our willingness to develop and participate cooperatively in these programs when the Commission so requires and to share that information and its results.

In terms of compliance requirements, Honduras respects all current conservation measures, such as the capacity limits established for tuna vessels, so there have been no information requirements regarding alleged infractions.

We are pleased to inform you that Honduras has enacted Decree No. 106-2015 of August 5, 2017, of the new Fisheries and Aquaculture Law, which guarantees management and conservation measures to ensure compliance with observer programs, inspections at sea and in port, and Vessel Monitoring Systems (VMS). In this way, the capacity to respond to alleged infractions to the IATTC measures by our vessels is improved and the readiness and willingness to continue communicating to the IATTC the different actions that are taken, for instance against vessels that commit infractions, is maintained.

We also declare Honduras readiness to participate as an observer in the plenary, subsidiary and scientific meetings of the IATTC.

In this context, Mr. Director, I kindly ask you to incorporate the request of Honduras regarding the renewal of the status of Cooperating Non-Party in the agenda of the 93<sup>rd</sup> meeting of the IATTC, to be held next August in San Diego, and in which we plan to accredit a Delegation from Honduras.

# INDONESIA'S APPLICATION FOR COOPERATING NON-MEMBER STATUS OF INTER-AMERICAN TROPICAL TUNA COMMISSION (IATTC)

#### I. Introduction

Indonesia is one of the largest tuna producing countries in the world. Tuna resources are spread out almost all over Indonesia waters include archipelagic and territorial waters as well as IEEZ. Contribution of tuna fishery both to gross domestic product (GDP) and working opportunity cannot be ignored. Tuna also is one of the primary export commodities that are exported in various products such as fresh tuna, frozen tuna, canned tuna. In 2017, export of tuna products (fresh, frozen and canned) mostly to China, USA, Japan, EU, Chinese Taipei, Australia and ASEAN Countries.

As we are aware, Regional Fisheries Management Organisations (RFMOs) are of central importance to sustainable management tuna resources in the world. In 2004, the Government of Indonesia has drawn line policies according to Fisheries Law No. 31 of 2004 which is also based on UNCLOS 1982. The Law has explicitly provided room for the Government of Indonesia to participate actively in the membership of body /institution/organization at the regional or international level with respect to the cooperation for regional and international fishery management, such as cooperation for conservation and management of straddling and highly migratory fish stocks through existing RFMOs.

Currently, Indonesia has actively participated in the Regional Fisheries Management Organizations (RFMOs) namely: (i) Indian Ocean Tuna Commission (IOTC) as a member since 2007, (ii) Commission for the Conservation of Southern Bluefin Tuna (CCSBT) as a member since 2008. and (iii) Western and Central Pacific Fisheries Commission (WCPFC) as a member since 2013. This participation refletes a commitment of Indonesia to be involved in achieving sustainable fisheries management through international cooperation.

Since 2004, Indonesia has participated in IATTC Annual Meeting and renew the status annually. With reference to the Resolution C-07-02 on Criteria for Attaining the Status of Cooperating Non-Party or Fishing Entity in IATTC, Indonesia would like to renew the status of Indonesia as Cooperating Non Member to the IATTC for the year of 2018/2019. Indonesia strongly believes that Indonesia's membership could improve its role and give strong foundation for strengthening future cooperation through Regional Fisheries Management Organizations (RFMOs).

### II. Submission of Indonesia fulfillment requirements become Cooperating Non Member of IATTC as required in Resolution C-07-02

### a. Information requirements

Communicate full data on its historical fisheries in the LATTC area, including nominal catches, number/type of vessels, name of fishing vessels, fishing effort and fishing areas;

There was no Indonesia flagged vessels operating in the convention area of IATTC.

Communicate annually catch and effort data and size-frequency distribution of the catches (when possible) in due time and appropriate format for scientific evaluation of the stocks;

Indonesia did not have any catch and effort data and size-frequency distribution of the catches in IATTC area.

Communicate details on current fishing presence in the area, number of vessels and vessel characteristics:

There was no Indonesia flagged vessels operating in the convention area of IATTC.

Communicate research programs it has conducted in the LATTC area and share the information and the results with the LATTC.

None. Indonesia did not conduct research programs in the IATTC area.

### b. Compliance requirements

Respect all conservation measures in force in LATTC

Indonesia commits to cooperate in the implementation of conservation and management measures adopted by IATTC. Indonesia also will ensure, to greatest extent possible, its nationals policy comply with the provisions of the Convention and conservation and management measures adopted by IATTC.

Respect the capacity limits already in force in IATTC for tuna vessels;

None. There was no Indonesia flagged vessels operating in the convention area of IATTC.

Inform the LATTC of all the management and conservation measures it takes to ensure compliance by its vessels, including inter alia and as appropriate, observer programs, inspection at sea and in port, and Vessel Monitoring Systems (VMS);

Liberia remains committed to the implementation the IATTC's Conservation and Management Measures (CMMs). In accordance with provisions set out in Resolution C-07-02 (Criteria for Attaining the Status of Cooperating Non-Party in IATTC), Liberia is submitting the following information in support of its request:

### A. Information Requirements:

 Full data on historical fisheries in the IATTC area, including nominal catches, number/type of vessels, name of fishing vessels, fishing efforts:

Liberia does not have fishing/donor vessels in the IATTC Area; however, Liberia does have a number of receiving/carrier vessels in the Area. A list of those vessels is attached.

Annual catch and effort data and size-frequency distribution of catches...scientific evaluation of stocks:

Liberia does not have fishing vessels in the IATTC Area; therefore, there is no catch effort or scientific evaluation to report.

Details on current fishing presence in the area, number of vessels and characteristic:

Liberia has several carrier vessels operating in the Area. Please refer to attached list for additional details on those vessels. Transshipment data/report for those vessels that received

tuna and tuna-like species in the IATTC Convention Area will be provided by 30 September 2018.

Research programs conducted in the IATTC area the results:

Liberia has not conducted any research programs in the Area.

Commitment to respect the capacity limits already in force in IATTC for tuna vessels:

Liberia makes an explicit commitment to respect the capacity limits set by the LATTC for tuna vessels, preventing additional vessels from entering already over-crowded fisheries.

 Inform the IATTC of all the CMMs Liberia takes to ensure compliance by vessels, including observer programs, inspection at sea and in port, and Vessel Monitoring Systems (VMS):

<u>Monitoring</u>: Liberia has established Vessel Monitoring System (VMS) requirements for all vessels engaged in transshipment operations. Further, Liberia recently commissioned a Fish Monitoring Center (FMC), which is manned 24 hours and has the capability to track and report on Liberian and foreign vessels.

<u>Inspection/Investigation</u>: Liberia has approximately 400 flag State inspectors at all major shipping ports. If one of our vessels is suspected of illegal activity, said vessel can be ordered to port pursuant to Liberian Maritime Law/Regulations for an investigation. If it is determined that a violation has occurred, a penalty may be imposed or the vessel's Certificate of Registry can be revoked, depending on the severity of the violation.

Respond to alleged violations of IATTC measures by vessels, as determined by the appropriate bodies, and communicate to IATTC the actions taken against the vessels: Liberia pledges to respond to alleged violations of IATTC measures by its vessels, as determined by the appropriate bodies, and shall communicate to IATTC the actions taken against those vessels.

Commitment to participate at plenary and relevant subsidiary and scientific meetings as deemed appropriate.

Liberia makes an explicit commitment to participate at plenary and relevant subsidiary meetings, as deemed appropriate.
