During the 95th annual meeting of the IATTC held by videoconference on November 30-December 4, 2020, it was agreed that an extraordinary meeting of the Committee for the Review of Implementation of Measures Adopted by the Commission would be held by videoconference in early 2021.

1. <u>DATES AND TIMES</u>: As discussed and coordinated with the Chairman of the Committee, Mr. David Hogan, and as already published on the Commission's website, this meeting will be held by videoconference on **29 and 30 March 2021**.
