Transshipment report 2024- Vanuatu

In accordance with paragraph 19 of Resolution C-22-03, Vanuatu hereby provides its 2024 transshipment report of Transshipment activities within the IATTC Convention area. Vanuatu's vessels that operate in the convention area are Large-scale Tuna-Fishing Vessels (LSTFVs).

All of Vanuatu's vessels who engage in Transshipment activities are required to notify the Management authority before conducting any at-sea Transshipments.

Transshipment activities are reported by way of submitting a Transshipment Notification 24 hours before a Transshipment activity takes place and a Transshipment declaration no later than 15 days after the transshipment activity has taken place.

In 2024, 8 Vanuatu flag LSTFVs carried out transshipment activities within the IATTC Convention area and the total quantities transshipped was 360 tons. The details for Transshipment activities by Vanuatu flag vessels can be referred to in Table 1,2 and 3 below.

Vanuatu's vessels that operate in the convention area are Large-scale Tuna-Fishing Vessels (LSTFVs). All of Vanuatu's vessels who engage in Transshipment activities are required to notify the Management authority before conducting any at-sea Transshipments. Transshipment activities are reported by way of submitted a Transshipment Notification 24 hours before a Transshipment activity takes place and a Transshipment declaration no later than 15 days after the transshipment activity has taken place.

In 2023, 11 Vanuatu flag LSTFVs carried out transshipment activities within the IATTC Convention area and the total quantities transshipped was 1,150.8 tons. The details for Transshipment activities by Vanuatu flag vessels can be referred to in Table 1 and 2 below.
