1. INTRODUCTION

The <u>Agreement on the International Dolphin Conservation Program (AIDCP)</u> entered into force on February 15, 1999, and as of December 31, 2002, Costa Rica, Ecuador, El Salvador, Guatemala, Honduras, Mexico, Nicaragua, Panama, Peru, United States, Vanuatu, and Venezuela have ratified or acceded to the Agreement, and Bolivia, Colombia, and the European Community are applying the AIDCP provisionally.

During 2002, the International Review Panel (IRP) consisted of 21 members: the 15 participating governments that have accepted the Agreement, and 6 representatives of non-governmental organizations (NGOs), 3 from environmental organizations and 3 from the tuna industry.

This Annual Report, which covers the tenth year of operation of the IDCP, summarizes those aspects of the operation of the fleet relating to the implementation of the AIDCP. The minutes of the meetings of the Parties, the IRP, and other documents referred to in this report are available on the IATTC web site (www.iattc.org).

2. OBSERVER PROGRAM

The coverage of the international fleet by the On-Board Observer Program in 2002 is summarized in Appendices A and B.

During 2002 the Program sampled 99.3% of trips by vessels covered by the AIDCP, and the IATTC program sampled over 68% of all trips. All of the six trips not sampled were by one vessel. The flag of registry of the first of those trips is unknown to the Secretariat and the subsequent five trips were under Bolivian flag. Despite instructions from the Bolivian government to do so, vessel management refused to carry observers during those trips.

There was some doubt about whether one vessel which is close to the size required by the AIDCP to carry an observer should have carried an observer. In the event, the flag government determined that the vessel was of less than 363 T carrying capacity and was not required to carry an observer.

At the 7th Meeting of the Parties, the European Union informed the Parties that it would establish its own on-board observer program and that the program would assign observers to 50% of the trips made by EU vessels that are now fishing under the AIDCP. The EU program began in early 2003.

3. DOLPHIN MORTALITY LIMITS (DMLs)

3.1. 2002 DMLs

The overall dolphin mortality limit (DML) established for the international fleet in 2002 was 5,000, and the unreserved portion was 4,900. Ninety-one vessels requested a DML, including seven that were allowed an extension by the IRP until the end of 2001 to become qualified for a DML. Based on those 91 requests, the average individual-vessel DML (ADML) was 53.846. All but one of the seven vessels did qualify for a DML by the end of the year, and the DML of the vessel that did not qualify was reallocated during 2002. Thus 90 vessels were allocated full-year DMLs. Two of those vessels had exceeded their 2001 DMLs, so their 2002 DMLs were reduced in accordance with Annex IV (III) 6 of the AIDCP.

Of the 19 vessels that did not utilize their DMLs prior to April 1, 2002, seven forfeited their DMLs, and 12 were allowed to keep them for the remainder of the year under the *force majeure* exemption allowed by the AIDCP. A total of 77 vessels utilized their DMLs during the year, and the average mortality per vessel was 18.8 dolphins. One vessel was allocated, and utilized, a second-semester DML of 17. The distribution of the mortality caused in 2002 by vessels with full-year DMLs is shown in Appendix C.

During 2002 the Secretariat sent 4 quarterly performance letters, all at the end of the first quarter, to vessels that risked exceeding their assigned DML if their mortality levels continued to accumulate at the current rate. No vessel exceeded its DML in 2002.

The preliminary estimate of the total dolphin mortality in the fishery in 2002 is 1,514, or about 30% of the overall limit of 5,000. The preliminary estimate of the total number of intentional sets on tunas associated with dolphins is 12,433 and the average mortality in these sets is approximately 0.12 dolphins.

3.2. 2003 DMLs

Ninety-one vessels requested and received DMLs in 2003 from the unreserved portion (4,900) of the overall fleet mortality limit. The ADML is 53.846. One vessel will be allocated a second-semester DML.

3.3. DML allocation and adjustment procedures

The 7th Meeting of the Parties agreed to amend Annex IV (I) 8 and Annex IV (III) 4 of the AIDCP to lengthen the time frame of occurrence of infractions that affect initial DML assignments and their

adjustments.

3.4. Utilization of second-semester DMLs

The 8th Meeting of the Parties agreed to amend Annex IV (II) 1 of the AIDCP to change the deadline for utilization of second-semester DMLs from December 31 to October 1.

3.5. Exemption of force majeure or extraordinary circumstances

The 7th Meeting of the Parties granted a vessel a *force majeure* exemption and allowed it to fish with a DML in 2002 even though the deadline for requesting such an exemption was not met, due to special circumstances. The vessel received a DML of 17 dolphins from the Reserve DML Allocation established by the AIDCP. The Secretariat was later informed by the flag Party that the vessel would not fish for the rest of the year, and at its 31st meeting the IRP decided that this non-utilization of a DML would count against the vessel with respect to the provision in Annex IV (II)1 that any vessel that loses its DML on two consecutive occasions shall not be eligible to receive a DML for the following year.

3.6. Reports of dolphin mortality by observers at sea

During 2002 the weekly At-Sea Reports by observers of dolphin mortalities by stock were received from approximately half the vessels at sea, as follows:

4. INFRACTIONS AND SANCTIONS

4.1. Decisions regarding infractions

The 8th Meeting of the Parties adopted the <u>*Resolution on a Definition of a Pattern of Infractions*</u>, and agreed that the consequences of a determination that a vessel has engaged in a pattern of infractions, that

no DML shall be assigned to that vessel, would affect a DML for the year after the determination only.

During the year the IRP discussed cases of vessels under 363 T capacity that were reported to be setting on dolphins without a DML and without an observer on board, especially the case of one vessel that was detained within the waters of another Party with dolphins in its net. This issue led to the 8th Meeting of the Parties adopting the <u>Resolution on Vessels of Less than 363 mt Capacity</u>, which requires those vessels of less than 363 metric tons carrying capacity that have been identified by the IRP to have possibly committed an infraction by intentionally setting on dolphins to carry observers.

Appendix D includes summary tables of responses, by country, regarding six types of possible infractions

(observer interference, use of explosives, night sets, fishing without an observer, sets on dolphins after reaching the DML, and fishing on dolphins without a DML) identified by the IRP during the three meetings.

Appendix E lists all the possible infractions identified during the period covered by this report, and reported by the Secretariat to the governments under whose jurisdiction the vessels in question operate. Each country's vessels, identified only as 1, 2, *etc.*, are listed in random order with the trips during which possible infractions occurred. Only vessels identified as having committed possible infractions are included. Each trip is identified by its IRP record number (example: 2002-123) followed by the IRP meeting date (year/month) at which the possible infractions were identified. Each possible infraction is listed, followed by a brief description of the action taken by the government, as reported to the Secretariat; if no action is listed, this indicates that the Secretariat has not received a response from the government.

5. OTHER ISSUES

5.1. Decisions regarding fleet operations

At its 31st meeting, the IRP agreed that vessels applying for 2003 DMLs would have until November 1, 2002 to pay their 2003 vessel assessment fee.

The 7th Meeting of the Parties approved the following documents which were forwarded to it by the IRP:

- 1. <u>Procedures for maintaining the AIDCP List of Qualified Captains</u>. This revised the system for training and identification of fishing captains qualified to fish on vessels with DMLs.
- 2. <u>Technical guidelines to prevent high mortality during sets on large dolphin herds</u>. It was recommended that these be incorporated as an element of captain training.
- 3. Procedures for dealing with special problem sets.

The 7^{th} Meeting of the Parties also approved a modification to Section 3 of the <u>System for Tracking and</u> <u>Verifying Tuna</u> regarding the dolphin-safe status of tuna caught by a vessel that fishes both inside and outside the AIDCP Agreement Area during a single trip.

5.2. Pending business

The IRP is in the process of developing a system to measure DML utilization to deter frivolous DML requests. It is also considering amending Annex IV of the AIDCP to change the deadline for requesting second-semester DMLs so as to possibly reduce frivolous requests for those DMLs.

The IRP is considering recommending to the Parties that the AIDCP be amended to express the definition of vessel capacity in well volume in cubic meters instead of carrying capacity in metric tons, and to require Class-5 vessels (272-363 T carrying capacity) to carry observers.


