Dear Dr. Franco,

With reference to Paragraphs 7 and 11 of Resolution C-23-08, we would like to kindly inform you that, based on our available data, none of our fisheries using surface longlines have recorded an average catch of silky sharks exceeding 20% by weight in the eastern Pacific Ocean. Therefore, our longline vessels do not fall under the definition of "surface longline fisheries" as outlined in Paragraph 7 of the Resolution. Accordingly, the application of measures regarding the use of steel leaders is not required for our vessels in the upcoming year.

Furthermore, we would also like to note that we don't have any purse-seine vessels operating in the EPO. As such, the submission of information requested under Paragraph 13 of the Resolution is not applicable in our case.

In accordance with Paragraphs 7 and 11 of Resolution C-23-08, I am writing to inform you that none of our fisheries using surface longlines have captured more than 20% of silky sharks by weight on average in the EPO. Therefore, our longline vessels operating in the EPO do not meet the definition of surface longlines as outlined in Paragraph 7 of Resolution C-23-08. As a result, there is no need to impose restrictions on the use of steel leaders for our fishing vessels next year.
