- A. **Dates and venue:** Please be informed that the AIDCP meetings will be held 17-19 October 2022 at the Johnson House (T-29) located at Scripps Institute of Oceanography, 8840 Biological Grade, La Jolla, Ca 92037 from 9:00 AM to 1:00 PM local time.

The IATTC Secretariat has secured a special room rate for standard occupancy at the Hotel Inn by the Sea, located in 7830 Fay Avenue, La Jolla, Ca 92037, the Secretariat will provide shuttle service to and from the hotel for your convenience. - C. **Special arrangements:**
