In response to your memorandum (Ref. 0566-410, December 17, 2021), and as a correction to the initial letter sent to you on March 24, 2022, the United States is providing updated point of contact information for notice of arrival. The information on inspection reports, designated ports, and review of templates remains the same as the original letter, but is repeated here for ease of reference.

The U.S. point of contact (POC) for the purpose of receiving notices of arrivals from foreign-flagged fishing vessels seeking to enter U.S. ports is the United States Coast Guard (USCG). The specific USCG POC differs depending on the U.S. port.
