Re: 98th meeting or the Commission by videoconference (23-27 August 2021)

In this memorandum, I wish to refer to the 98th meeting of the Commission to be held by videoconference from 23-27 August 2021, starting at 3:00 p.m. PDT San Diego time.

As already announced on the Commission's website, several AIDCP meetings and meetings of IATTC subsidiary bodies will be held during the previous week. For the sake of ensuring equitable treatment among participants located in the time zones that are the farthest away from San Diego, those meetings will begin at 8:00 a.m. PDT San Diego, California, time.

Now, I wish to emphasize that the objective to be achieved at the August meeting is to reach a decision on conservation and management measures for tropical and temperate tunas. For this reason, the provisional agenda (see Annex 1) is focused only on the negotiation and adoption of these measures, excluding all other issues which will be considered later at the October meeting (see Annex 2).

To achieve this objective, it is therefore imperative to multiply all necessary efforts before the August meeting to bring positions closer together and to work actively towards the preparation of a consensus, including through **informal consultations**.

I am pleased to note that this process has already started and I wish to reiterate that the Director, the Commission's staff and I remain at the complete disposal of all members to facilitate this process and to respond effectively and efficiently to all requests made in this context.

It is also important to anticipate and program all the necessary arrangements so that this process of bringing together, exchanging views and negotiating can continue to be carried out during the August meeting, aside from the formal videoconference sessions. These arrangements should be as practical, efficient and agile as possible, with the possibility of informal consultation meetings by videoconference, or face-to-face or hybrid meetings for those delegations that so choose, as some members have already proposed.

On that occasion, as the Director and the staff of the Commission, I will be at the disposal of members to provide as much support as possible to this process of informal consultations
