**AIDCP BUDGET**

The information in Table 1 of this document further supports the Secretariat's conclusions presented in document [MOP-25-06](#) at the Meeting of the Parties held on 19 June 2012. In that document, the Secretariat proposed three scenarios for vessel assessment increases based upon the current composition of the Regional Vessel Register. The three scenarios for expenditures in 2013 were based upon the current rate of USD 14.95/m<sup>3</sup> and the proposed rates of USD 18.00 and USD 19.15/m<sup>3</sup>. The only difference between the scenarios is related to the variable costs of the observers (*i.e.* wages, travel, equipment, and training).

Column 1 of Table 1 reflects the 2012 agreed budget, Column 2 reflects the actual costs for the eight months ended 31 August 2012, and Column 3 presents an estimated forecast for the year ending 31 December 2012. Based on the figures in Column 2, the Secretariat maintains its position that an immediate increase in assessments up to USD 19.15/m<sup>3</sup> is necessary.
