# IATTC IUU VESSEL LIST

IATTC Resolution <u>C-15-01</u>, which amended and replaced IATTC Resolution C-05-07, requires the establishment of a list of vessels presumed to have carried out illegal, unreported and unregulated (IUU) fishing activities in the eastern Pacific Ocean (EPO), based on information collected by Members and Cooperating Non-Members (CPCs) and from any other relevant sources.

In addition to describing in detail the procedure for compiling the List, Resolution C-15-01 also establishes, *inter alia*, that:

- 1. The Committee for the Review of the Implementation of Measures Adopted by the Commission (Review Committee) shall each year examine the provisional IATTC IUU Vessel List, as well as the information that supports the inclusion, and shall remove a vessel from the provisional IATTC IUU Vessel List if the vessel's flag State demonstrates that:
  - a. The vessel did not engage in any of the IUU fishing activities described in paragraph 3 of Resolution C-15-01, or
  - b. Effective action has been taken in response to the IUU fishing activities in question, including, *inter alia*, prosecution, and imposition of sanctions of adequate severity.
- 2. Following the examination referred to in the above paragraph, the Review Committee shall recommend that the Commission approve the provisional IATTC IUU Vessel List, as amended by the Review Committee.

As notified by the Director to the CPCs (memorandum ref. 0244-410 dated 01 June 2017) and as of the date of preparation of this document, one vessel was proposed by a CPC for inclusion in the IUU List and, therefore, included in the draft IUU list (Appendix A).

It should also be recalled that, as recommended by the Committee at its 7<sup>th</sup> meeting, the Director asked Fiji to submit additional information in support of their request for removal of the vessel Xin Shi Ji 16 from the current IUU list. The information sent by Fiji was circulated with my memorandum 0014-581 dated 12 January, 2017 (Appendix B).

The vessels on the current IUU Vessel List will remain on that list until the Commission decides otherwise.

### Notes to List of Past and Present Members

- If the return for either of the two immediately preceding years has given as at the date of that
  return the full particulars required as to past and present members and the shares and stock held
  and transferred by them, only such of the particulars need be given as relate to persons ceasing to
  be or becoming members since the date of the last return and to shares transferred since that date
  or to changes as compared with that date in the amount of stock held by a member.
- If the names in the list are not arranged in alphabetical order, an index sufficient to enable the name of any person to be readily found must be arranged.

### Notes to Particulars of Director and Secretaries

"Director" includes any person who occupies the position of a director by whatsoever name called, and any person in accordance with whose directions or instructions the directors of the company are accustomed to act.

"Surname", in the case of a peer or a person usually known by a title different from his surname, means that title.

"Former forename" and "former surname" do not include -

- (a) in the case of a peer or a person usually known by a British title different from his surname, the name by which he was known previous to the adoption of or succession to the title; or
- (b) in the case of any person, a former forename or surname where that name or surname was changed or disused before the person bearing the name attained the age of eighteen years or has been changed or disused for a period of not less than twenty years; or
- (c) in the case if a married woman the name or surname by which she was known previous to the marriage.

The names of all bodies corporate incorporated in Fiji of which the director is also a director, should be given, except bodies corporate of which the company making the return is the wholly-owned subsidiary or bodies corporate which are the wholly-owned subsidiaries either of the company or of another company of which the company is the wholly-owned subsidiary. A body corporate is deemed to be the wholly-owned subsidiary of another if it has no members except that other and that other's wholly-owned subsidiaries and its or their nominees. If the space provided in the form is insufficient, particulars of other directorships should be listed on a separate statement attached to this return.

Dates of birth need only be given in the case of a company which is subject to section 187 of the Act.
